That is why, we are pleased to make known you the development of a new software for the recording of the data of the CAMRegis family.

The new application, called **SOFTRegis**, is a management and monitorization software for the recordings mentioned above, and which is compatible with models **AKO-15740**, **AKO-15742**, **AKO-15750** and **AKO-15752**, in addition te being compatible with future data's recorders which is develop within AKO.

Please, **note** that the software **AKO-5003 v.1.6.3**, which is the currently available version will be compatible with the old models AKO-15715, AKO-15716, AKO-15720 and AKO-15722.

Distribution of SOFTRegis, will be done thanks to CDs, of two formats, for two different cases :

1. **CD in a white plastic pocket**, inside the packaging of data's recorders. This option will be available from the launching of new **version 3.0.0 of CAMRegis**.
2. **CD in a rigide case standart DVD**. This option will be the same there is currently with software AKO-5004. It is adressed to customers who have already a Data's recorder CAMRegis, and which using current version 1.6.3 of AKO-5003 to discharge datas and which want to replace it by new SOFTRegis.

Until the launching of the new versions of recorders, the only way to obtain SOFTRegis is through **option 2**.

So, even if it is a **free software** you will have to order it as a reference in your catalogue, which is :
